

- Also met the team from MHCLG visiting the site in connection with the international enquiry.




Town Centres – Bringing Individuals Back to Our Town Centres




Town Centres – Restoration of Bridgwater Docks



- Restoration of an historic area
- Re-energises the town centre by creating a new leisure destination diversifying the activity in the centre.
- Creates a growth in tourism
- Increased visitor numbers which links with Celebration mile etc

Town Centres – Northgate Yard



- Sedgemoor District Council has committed to funding and delivering this programme of work in excess of £15m which includes: -
- State of the art 7 screen cinema
- 8 lane bowling alley
- 4 restaurant units
- Public realm improvements
- Creation of formal town centre park




Town Centre – Community Renewal Fund (CRF)

- £220m of additional funding to assist the transition from the EU Structural fund programme towards the UK Shared Prosperity Fund.
- Scheme identifies 100 ‘priority places’ – SDC, Mendip and SSDC identified within this.
- Bids up to £3m per place but only lead authorities can bid – in our case this is Somerset County Council
- 90% of the funding will be for revenue with rest for capital projects
- Focus on supporting innovation and investment in pilot schemes as well as demonstrating contribution to net zero and environmental objectives
- Deadline for shortlist of projects to SCC was 10th May and to Government by 18th June
- Projects must have spent funding and delivered outputs/outcomes by March 22

Town Centre – CRF Bids Submitted

- **Highbridge Regeneration** – for design and feasibility for a range of projects within Highbridge
- A joint **Sedgemoor/Mendip place based approach to tourism** – to develop an active sustainable tourism strategy
- **Bridgwater Docks** – to deliver the significant design and feasibility work along with business planning and viabilities studies
- **Carnival Workshops** – to deliver the design and feasibility work associated with Carnival project.






Levelling Up Fund – A38 Bridgwater Northern Corridor

- **Package Elements:**
- Dunball Junction – Partial traffic signal ‘through-about’ for highway capacity improvement and cycle provision. £4.225m. BCR 23.9.
- Canon/Cross Rifles junction Improvement - Amended layout for highway capacity improvement and cycle provision. £7.003m. BCR 8.5.
- Active Travel Infrastructure - £3.442m. BCR 2.82.
- Total corridor cost = £14.670m

- **Compliance with bid criteria:**
- Predicted spend in 21/22 financial year = £2.837m.
- Local contributions = £4.612m (31%) with the ‘ask’ of the levelling up fund just over £10m.
- Lies in ‘Category 1’ priority ‘levelling up’ area.
- Overcomes key infrastructure constraints to achieving local plan growth.
- Strong Active Travel component - will help improve the standard of cycling infrastructure in-line with new government policy (‘Gear Change’) and guidance (LTN 01/20) on cycling.
- Has MP support.
- Very high value for money for the combined package (Overall BCR 9.3).




Environmental Statement Update

- EIA Screening Opinion provided on 23rd June – Schedule 2 and ES required
- EIA Scoping Report – out for consultation between 6th July and 3rd August. Council will then provide Scoping Response
- Environmental Statement:
 - Currently being prepared
 - Will be informed by Scoping Response
 - Tie in with Design Guide for mitigation
 - Includes several appendices, including: Transport Assessment, baseline economics study, Waste Strategy, FRA and Water Management Strategy
- Client and Legal Review of ES in August.
